REGULAR MEETING MINUTES FOR MONDAY, MAY 10TH, 2021 AT 6:30 P.M.

- I. Due to the Covid-19 Health Crisis the council meeting was held in person by the Council and electronically through GoToMeeting for the public as allowed by Section 21.8 of the Iowa Code. Mayor Parker opened the council meeting at 6:30 p.m. and called Roll. Council members present were Brian Dorsett, Tom Flanery, Shane Gliem, and Stan Landon. Curtis Thornberry was absent. Staff attending Lisa Grossman-City Administrator.
- **II. Approval of Agenda** Landon made a motion to approve the agenda, seconded by Dorsett. Motion carried unanimously.

- **IV. Consent Items** Gliem moved to approve the minutes of 04-26-21 Regular Meeting, seconded by Landon. Motion carried unanimously.

ORDINANCE NO. 340

AN ORDINANCE AMENDING THE CITY CODE OF THE CITY OF PANORA, IOWA, BY AMENDING PROVISIONS RELATED TO WATER SERVICE CHARGES

BE IT ENACTED by the City Council of the City of Panora, Iowa;

SECTION 1. SECTION 92.02 MODIFIED. Section 92.02 of the Panora Code of Ordinances, is repealed and the following adopted in lieu thereof:

92.02 RATES AND SERVICES Water service shall be furnished at the following monthly rates within the City upon date of passage until amended:

ORDINANCE 341

AN ORDINANCE AMENDING THE PANORA CODE OF ORDINANCES BY AMENDING PROVISIONS RELATED TO SEWER SERVICE CHARGES.

BE IT ENACTED by the City Council of the City of Panora, Iowa:

SECTION 1. SECTION 99.02 MODIFIED. Section 99.02 of the Panora Code of Ordinances is hereby repealed and the following adopted in lieu thereof:

99.02 RATE

- Purpose. The purpose of this chapter is to collect from all users of the City sewer system the cost in whole or in part of constructing, maintaining and operating the main sewers and sewage treatment plant in proportion to the service provided to each user.
- 2. Sewer System Defined. For use within this chapter a "sewer system" is composed of main sewers, sewage pumping stations, treatment and disposal plants including aerated lagoons, lateral sewers, drainage conduits or channels and sewer connections in public streets for private property.
- 3. Established General Customers. There are established as just and equitable monthly charges, rates or rentals for the use of and the service rendered by the sanitary utilities which shall be paid by the owner of each and every lot, parcel or real estate or building or premises situated within the corporate limits of the city that is connected with and uses the sanitary utilities by or through any part of the sewage system of the city, or that in any way uses or is served by the sewage system of the city, or that in any way uses or is served by the sewage treatment plant or otherwise discharges sanitary sewage, industrial waste, water or other liquid either directly or indirectly into the sewage system of the city, in accordance with the below schedule. For those customers that own vacant lots with no structures on the lot, no "sewer availability charge" will be billed.

- 4. Established Industries. A. An "industrial user" shall be any individual, business, corporation or other legal entity discharging any waters or wastes in excess of (1) a five-day biochemical oxygen demand greater than two hundred parts per million by weight, or (2) containing more than two hundred parts per million by weight of suspended solids, or (3) containing more than twenty parts per million by weight of Ammonia Nitrogen, or (4) having an average daily flow greater than five percent of the average sewage flow of the city.
 - B. All industrial users shall pay a rate according to the following:

- C. No industrial user, under any circumstance, shall be permitted to discharge any waters or wastes containing toxic or poisonous solids, liquids, or gases in sufficient quantity, either singly or by interaction with other wastes, to injure or interfere with any sewage treatment process, constitute a hazard to humans or animals, create a public nuisance, or create any hazard in the receiving waters of the sewage treatment plant, in organic chemical discharges.
- 5. Established Outside City Limits. A. The schedule of monthly service charges, rates or rentals as specified in Sections 3 and 4 shall apply respectively to general customers within the city limits and industrial customers, whether within or outside the city limits. General customers outside the city limits shall pay the following rate:

These rates are exclusive of tax for any period or fraction thereof.

6. Computation Procedure. The service charge, rate or rental as provided in Sections 3, 4, and 5 shall be applied to the quantity of water used and discharged into the sewage system of the city as determined by the water meter readings of the municipal waterworks of the city or by separate sewage flow meters and samplers and by such privately owned water supplies as may contribute to the sewage system, and in the case of unmetered water supplies, the quantity of water used and discharged into the sewage system of the city shall be determined to the satisfaction of the city's wastewater utility at the expense of the owner of the unmetered water supply. If the estimated quantity of water from any unmetered supply equals in excess of an average of 3,000 gallons per day, the city may require that such water supply be metered at the expense of the owner of such water supply. The city shall be considered an owner within the meaning of this chapter as to city-owned property.

SECTION 2. REPEALER. All ordinances or parts of ordinances that are in conflict with this ordinance are hereby repealed.

SECTION 3. SEVERABILITY. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

SECTION 4. <u>WHEN EFFECTIVE.</u> This ordinance shall take effect following its final passage, approval, and publication as provided by law, or June 1, 2021.

- B. Dorsett moved to approve the monthly financials, seconded by Landon. With the roll being called, the motion carried unanimously.
